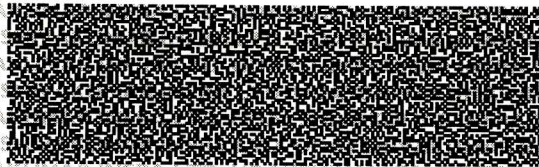
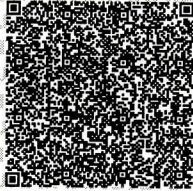

This **FIRST AMENDMENT AGREEMENT TO THE REGISTRAR AGREEMENT DATED SEPTEMBER 20, 2022 (this "First Amendment Agreement")** is entered into on **February 23, 2023 ("Effective Date")** at **Mumbai** among:

(A) **MAS SERVICES LIMITED**, a public limited company incorporated under the Companies Act, 2013 and whose registered office is situated at T-34, 2nd floor, Okhla Industrial Estate, Phase – II, New Delhi – 110 020, India ("**Registrar**", which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors, executors, administrators and permitted assigns).

AND

Handwritten signature and blue circular stamp: Udayshivakumar Infra DAVANAGERE

Statutory Alert:

- (B) **UDAYSHIVAKUMAR INFRA LIMITED**, a public limited company incorporated under the Companies Act, 2013, and whose registered office is situated at 1924A/196, Banashankari Badavane, Near NH-4 Bypass, Davangere – 577 005, Karnataka, India (the “**Company**”, which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors, executors, administrators and permitted assigns);

In this Agreement,

- (i) The Registrar and the Company are collectively referred to as the “**Parties**” and individually as a “**Party**”.

WHEREAS:

- (A) The Registrar and the Company had executed a registrar agreement dated September 20, 2022 (“**Registrar Agreement**”) in connection with the Issue.
- (B) The Company had filed the draft red herring prospectus dated September 27, 2022 (“**DRHP**”) with the Securities and Exchange Board of India (the “**SEBI**”), BSE Limited and National Stock Exchange of India Limited, for review and comments in accordance with the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 (the “**ICDR Regulations**”). Thereafter, the Company proposes to submit the draft of the red herring prospectus to SEBI after incorporating the comments and observations of SEBI on the DRHP. Subject to prevailing market conditions and other considerations, the Company thereafter proposes to file the red herring prospectus and the prospectus with the Registrar of Companies, Karnataka at Bangalore, SEBI and the Stock Exchanges in accordance with the Companies Act, 2013 and the ICDR Regulations.
- (C) The Company wishes to revise the size of the Issue in the red herring and the prospectus.
- (D) In order to facilitate the Issue, the Parties have agreed to enter into this First Amendment Agreement to reflect the revision in the Issue.

1. DEFINITIONS AND INTERPRETATION

- 1.1 Capitalized terms used, but not defined herein, shall, unless the context otherwise requires, have the meanings given to them in the Registrar Agreement.
- 1.2 Rules of construction set out in Section 1 of the Registrar Agreement shall, unless the context otherwise requires, apply to this First Amendment Agreement *mutatis mutandis*.
- 1.3 Unless the context otherwise requires, any reference to the Registrar Agreement shall be construed to mean the Registrar Agreement as amended by this First Amendment Agreement and this First Amendment Agreement shall constitute a part of, and shall be read together with the Registrar Agreement and shall constitute the entire understanding between the Parties.
- 1.4 All references to the Registrar Agreement in any other document, agreement and/or communication among the Parties and/or any of them shall be deemed to refer to the Registrar Agreement, as amended by this First Amendment Agreement.

2. AMENDMENT

2.1 Recital 1 of the Registrar Agreement shall stand replaced in its entirety and shall read as follows:

“1. The Company propose to undertake an initial public offering of equity shares of face value of ₹ 10 each of the Company (“Equity Shares”), for an amount aggregating up to ₹ 6,600 lakhs in accordance with the Companies Act (as defined herein below), the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the “SEBI ICDR Regulations”) and other Applicable Law (defined hereinafter) at such price as may be determined by the Company, in consultation with the Saffron Capital Advisors Private Limited (“BRLM”), in accordance with the book building process under the SEBI ICDR Regulations, (the “Issue Price” and the issuance the “Issue”). The Issue includes an offer within India, to Indian institutional, non-institutional and retail investors.”

2.2 Recital 2 of the Registrar Agreement shall stand replaced in its entirety and shall read as follows:

“2. The board of directors of the Company (the “Board”) has, pursuant to a resolution dated September 19, 2022 and February 21, 2023 and the shareholders of the Company by way of a special resolution adopted pursuant to Section 62 (1)(c) of the Companies Act, 2013 at the general meeting of the shareholders of the Company held on September 19, 2022 and February 21, 2023 approved the Issue.”

3. MISCELLANEOUS

3.1 Representation and Warranties

Each Party has the corporate power and authority or capacity, to enter into this First Amendment Agreement and this First Amendment Agreement shall be a valid and legally binding instrument, enforceable against each Party, in accordance with its terms.

3.2 Ratification and Confirmation



This First Amendment Agreement shall come into effect on and from the Effective Date. The Registrar Agreement shall stand modified to the extent stated in this First Amendment Agreement only. Except as expressly amended herein, all terms, covenants, and conditions of the Registrar Agreement, as amended, shall remain in full force and effect and are hereby ratified and confirmed by the Parties hereto. All terms of the Registrar Agreement, other than the terms amended by this First Amendment Agreement, shall apply *mutatis mutandis* to this First Amendment Agreement in the manner set forth in the Registrar Agreement.

3.3 Conflicts

In case of inconsistency between the Registrar Agreement and this First Amendment Agreement, this First Amendment Agreement shall prevail in relation to the provisions amended herein.

3.4 Governing Law

This First Amendment Agreement, the rights and obligations of the Parties hereto, and any claims or disputes relating thereto, shall be governed by and construed in accordance with the laws of India and subject to Section 3.5 of this First Amendment Agreement, the courts of Mumbai, India shall have jurisdiction in all matters arising out of this First Amendment Agreement.



3.5 **Arbitration**

Any Dispute arising out of or in relation to or in connection with this First Amendment Agreement shall be resolved in accordance with Section 49 of the Registrar Agreement.

3.6 **Counterparts**


